However, answer sheets for **Stage-III Test** will be evaluated only for those candidates who qualify the **Stage-II** (Skill Test). This is to reiterate once again that Stage-II (Skill Test) is qualifying in nature.

Candidates appearing in **Stage-II & Stage-III Test** must satisfy/verify their eligibility as per advertised criteria. If a candidate is found ineligible at any stage of recruitment process, he/she will be disqualified, his/her candidature may be cancelled & he/she will not be allowed to participate in subsequent selection process and if selected, appointment may be cancelled/ withdrawn. Hiding information or submitting false information may lead to cancellation of candidature at any stage of recruitment.
