Item No. 07.01

: To note the Agreement made with the Architect (M/s Mukesh & Associates) engaged by Institute.

Resolution

The Building and Works Committee noted the Agreement between Motilal Nehru National Institute of Technology Allahabad and Architect consultant M/s Mukesh & Associate 2/6, Ranganathan Avenue, Perumal Malai main road, Salem – 636003. The Architect was engaged as per existing rule of GFR.

The Building and Works Committee further resolved that M/s Mukesh & Associate will prepare complete Master plan without any extra cost. He shall integrate the old building of the campus with proposed new building.

A letter to that effect vide M & A/D2/BD/47BF/15-15/655 dated 18-2-2015 has been obtained from him, which will be used for getting environmental clearance.

Further a separate Consultant shall be engaged to obtain environment clearance for proposed new building of the Institute based on Master Plan.

The said proposal may be put up before finance Committee for ratification.

Item No. 07.02

: To consider the conceptual Design & Preliminary of the following Institutional building and award the work to M/s RITES ltd. or CPWD Allahabad.

- (i) Construction of Lecture Hall Complex
- (ii) Construction of Faculty Apartment
- (iii) Construction of Internal House, Block-C
- (iv) Construction of Additional floor in Main Academic Building
 [First Floor]
- (v) Extension of Hostel (Patel, Tilak, Malviya, & Tandon
- (vi) Dean Academic Block & CIR lab (Additional proposed first floor CIR block only)

Resolution

: The Building and Works Committee resolved that the Architect should make the presentation of Conceptual Design & Preliminary estimate of all the new proposed building to a Committee, before placing to Building and Works

Committee. The Committee so constituted will have an Architect as an external member.

Item No. 07.03

: To consider the revised Preliminary estimate & Drawing of Boys Hostel submitted by CPWD.

Resolution

: The Building and Works Committee Considered the revised Preliminary estimate of Boys Hostel of ₹ 98.60 crore, submitted by CPWD.

The Building and Works Committee further resolved that the diversion of nullah work should be under taken by CPWD and they should expedite the construction of Boys Hostel work. The following additional point to be ensured by CPWD without any additional cost on the estimated amount.

- (i) Elevator of the building should have one stretcher carrying capacity.
- (ii) Energy generator meter to be installed for solar panel generation.

Item No. 07.04

: To consider the detail estimate of Girls hostel submitted by M/s RITES Ltd.

Resolution

: The Building and Works Committee noted that the detail estimate of Girls Hostel is not required to place in meeting after approval of Preliminary estimate. M/S RITES should take approval of itemised specification from MNNIT, Allahabad and detailed estimate should be examined by Institute Engineers and Internal Auditor prior to the approval of the Competent Authority of M/S RITES.

The Building and Works Committee further resolved that the uniform specification must be adopted by both agencies.

Item No. 07.05

: To consider the Post facto approval on the request of M/s RITES Ltd. for component of price adjustment/escalation payment made to M/s IVRCL.

Resolution

The Building and Works Committee considered the component of price adjustment/escalation payment of ₹ 3,35,76,328.00 as submitted by M/s RITES ltd.

The Building and Works Committee further resolved that the calculation should be checked & certified by an Engineer of the Institute and Internal Auditor, before releasing the escalation cost based on the clause of 10 CC of CPWD.
