1. The Senate considered the reports of the examiners and the report of oral boards of the following Ph.D. students.

It approved the award of Ph.D. degree to the above three students on the basis of recommendation of examiners and oral board.

2. The Senate considered the Ph.D. thesis examiners report and viva-voce examination report of a Ph.D. student Mr. Raj Kumar Michael Stevens of Mechanical Engineering Department and recommended for the award of Ph.D. degree to the University of Allahabad.
3. The Senate approved the names of degree recipients of B.Tech., M.Tech., MCA, MMS and Ph.D. programmes for the award of degree in the Third Convocation to be held on November 11, 2006.
4. The Senate decided to adopt common norms for award of both Institute Gold Medals and sponsored Gold Medals and awards. The common norms would be same as approved by the Senate in its meeting held on 28.08.2005 with the following modification for M.Tech. degree programmes.

The first clause will be changed for M.Tech. students as follows :

*" If more than one students have the same CPI, then their SPI of same or previous semester will form the basis of this award. In case the selection is still not resolved, the inter-se merit of such candidates will be based on valid GATE-Score and the medal will be awarded to the candidate having maximum GATE-Score."*


All other clauses are applied as it is.


Further, it was decided that these norms would be applicable for the Third Convocation 2006.

5. The Senate, further decided to constitute and award 'The Certificate of Academic Excellence' to recognize the academic achievement of students who could not be awarded Gold medal (Institute or Sponsored) even though they have secured same CPI / Grade / Marks as of those who are selected for award of Gold medals. The Chairman, senate is authorized to approve the contents of 'The Certificate of Academic Excellence'.
